#### MARKET COMMENTARY


- From June 22<sup>nd</sup> to June 29<sup>th</sup>, the AAA MMD saw a 2bp increase in years 1 to 3, no change in years 4 to 5 and a 1bp increase in years 6 to 30.
- U.S Treasury rates increased 3 to 9 basis points across the curve.
- MMD/UST ratios for the 5Y, 10Y and 30Y decreased to approximately 63%, 67% and 89%, respectively.
- For the week ending June 28<sup>th</sup>, municipal bond funds experienced outflows of \$25.3 million after experiencing inflows of \$672.3 million the week prior.
- The new issue calendar for the holiday-shortened week shows approximately \$328 million in total par, composed of \$273 million in negotiated deals and \$55 million in competitive sales
- SIFMA reset 17 basis points lower this week to 4.01%

#### MMD Yield Curves






- 1-Yr Treasury
